## Summer Day Camp Fees

Summer Day Camp is a community service of LiveWell Athletic Club. The weekly fees and partial week fees are paid in advance on the first morning of attendance for the week the camper plans to participate. Dues can be paid by cash, check, credit card, or PayPal. PayPal instructions are on our website.

## Lunches

Each child is expected to bring a sack lunch, plainly marked with the child's name. No refrigerator or microwave is available. If your child has a need for a special drink, please notify our director. Water is available, water bottles are welcome.

## Schedule

Day Camp hours are 7:30am-5:30pm, Monday-Friday. There will be a minimum fee of \$10 or \$1 per minute (whichever is greater) assessed for children left after 5:35 pm or dropped off earlier than 7:25 am.

## Camp Registration

In addition to the weekly fee there is a one-time summer registration fee of \$29 per camper. This includes registration and a day camp T-shirt. Your child must be registered before June 15th to receive a camp T-shirt. The \$29 fee is due at the time of registration. We ask that you please pay all fees by credit card, debit card, cash, or check (payable to LiveWell Athletic Club). Remember that all fees are non-refundable and non-transferable and there is a \$25 fee for returned checks. Welcome! The LiveWell Day Camp Team is committed to providing a safe and fun environment for your child.

We are excited that your child will be joining us for a summer full of FUN, EXCITING, and ADVENTUROUS activities. We will work hard to make Live Well Day Camp a summer full of memories for your child. The following reminders will help to insure the safety and fun of every child.

## Arrival Procedures:

- If dropping your child off between 7:30 – 8:15, please drive to the back of the parking lot to the covered parking spots. A counselor will be waiting at the gate to let your child in.
- If dropping off after 8:15, please drop your child off at the front entrance.
- On Tuesdays and Thursdays, please have your child here by 9:00 am. If your child arrives after we have left on our field trips, you will be required to take your child to that location.
- Each Monday your child should enter LiveWell with weekly “fun stub” filled out. Payments can be made by cash, check, or credit card. **If you are paying by credit card, you will need to park your car and come to the front desk to pay for camp. PayPal can also be used. Instructions for PayPal are on our website.**
- Breakfast should be eaten before entering LiveWell.

## Dismissal Procedures:

- At 5:00, a LiveWell Team Member will be in the circle drive at the front entrance prepared to call for your child.
- Should you arrive before 5:00 to pick up your child, please stop by the front desk and they will radio for your child.
- Additional charges will be applied if you pick up your child after 5:30.

## Your child will need the following items (clearly labeled) daily:

- Sack lunch (Friday is Pizza Day)  
Should your child forget his/her lunch, a sandwich and chips will be provided and you will be charged \$5.
- Sunscreen
- Tennis shoes
- Snack or Snack Money (we will have concessions and snow cones available for purchase during swim time)
- Water Bottle
- Swimsuit (goggles)
- Towel

(Swimsuits can be worn under clothes as we will swim after lunch.)

## Day Camp Code of Conduct

LiveWell Day Camp offers a safe environment in which campers live, play and learn as part of a greater community. Camper attitude and behavior are critical to the success of the Day Camp community and each individual makes a difference in the quality of the camp experience. In order to create a community atmosphere, campers are asked to follow these behavioral guidelines during their Day Camp experience. Campers and parents/guardians must read and sign this agreement prior to camp attendance. This form may be submitted during the registration process or at the check-in registration on the first day of the camper's session.

- I will treat everyone at LiveWell Day camp with respect at all times, including showing respect for other's personal belongings, privacy and feelings.
- I understand that harassment or bullying of any kind will not be tolerated.
- I will respect the camp's facilities and equipment and will not take or destroy camp property. I will not misuse camp equipment and materials.
- I will not use obscene or foul language or gestures and I will not bring music with lyrics, which contain obscene or foul language or make reference to violent offensive actions.
- I will not engage in any activity, which may put myself, other campers, or staff at risk.
- I agree to abide by the rules and regulations of the camp and understand that I am expected to follow directions and guidance provided by the camp staff.
- I understand that I am responsible for any cell phones, video games or other expensive items brought to Day Camp, and that I may be asked to limit my use of these items.
- I acknowledge that LiveWell will not be responsible for loss or damage to personal property.

I understand that if a camper fails to abide by these behavioral expectations, the following steps will be followed:

1. The camper will receive a verbal warning from Day Camp staff for breaking rules.
2. After first warning, if behavior or actions still persists, the camper may be removed from that particular activity and given some "time out" to reflect on their behavior.
3. If behavior persists, camper(s) will be sent to the Day Camp office with a staff member, and Parents will be notified at this point and asked to assist in helping their camper make more positive choices.
4. If behavior or actions do not improve, parents will be notified that their child is being sent home. The camp director will discuss all decisions thoroughly before any child is sent home. **Campers asked to leave camp early for behavioral reasons will not receive a refund.** The camp director reserves the right to send home any camper if it is decided that it is in the best interest of the Day Camp program and campers.

**The following behaviors are considered very serious and will result in suspension or, and in some cases, immediate expulsion from camp: Possession or use of weapons, illegal drugs or other controlled substances, tobacco products of any kind or alcoholic beverage, Physical abuse of any kind including hitting, kicking, biting or pushing another camper or staff member, Failure to follow staff instructions thereby resulting in situations that put themselves, other campers or staff in physical danger, Leaving camp property or assigned program area without the permission of the staff member supervising the area or activity, Verbal abuse of or toward other campers or staff, which includes swearing, teasing or bullying, Behavior that is constantly interfering with the quality of the program other campers are receiving, Campers threatening to harm themselves or other campers.**

We have read and understand these behavioral expectations. Furthermore, we have discussed these expectations and agree to abide by them.

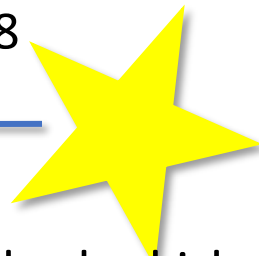
